Dr. Buggy also reported that ETS has suspended plans for a major change in GRE testing due to concerns over inadequate testing opportunities. Under the proposed testing format, the University of South Carolina Testing Center would have only been able to accommodate about 35 students for GRE testing in the upcoming year, approximately 1/10 of the total amount of tests taken in the past. ETS was invited to send a representative to visit USC to speak to Graduate Directors but they delayed until announcing the suspension of the proposed GRE.
