February 22nd, 2021

- 1. Call to Order and Approval of Agenda** (Jim Mensch, Chair)
The meeting was called to order at 2:02 p.m., and the agenda was unanimously approved.

- 3. Report of the Chair** (Jim Mensch)
Dr. Mensch welcomed all members and guests to the Graduate Council meeting.
- 4. Report of the Interim Dean of Graduate School** (Tracey Weldon-Stewart)
Dr. Weldon shared with the Council that there are at least two positions available within the Graduate School that will hopefully be filled by the end of this semester. These are both tied to some of the strategic initiatives that the Graduate School will be tasked with addressing. One will be in the area of data analysis and the other will support our efforts to increase minority recruitment efforts across the campus. The data analyst will be housed in the Provost Office but will also work part-time with

the Graduate School which will help us to have a bit more transparency with regards to our numbers. She will share more information as she knows it.

5. Report of the Secretary of the Graduate Council (Murray Mitchell)

Dr. Mitchell identified for participants that the meeting is being recorded, and continued participation represents informed consent to be recorded for this meeting.

Members were reminded that it is not too soon for us to begin the search for nominees for Graduate Council. As you know, members serve overlapping 3-year terms to facilitate some continuity to the business of Graduate Education for the University. We try to ensure representation across colleges. For those of you cycling off of the Council, please consider nominating a colleague who is qualified, interested, willing and available the 4th Monday of each month (2nd Mondays in December and May), from 2:00 p.m. to about 4:00 p.m. (allowing time for travel—assuming that one day, we return to campus full time). We also have five standing committees for any who may wish for a slightly different level of involvement with graduate education. There are two curriculum committees; a grievances, appeals, and petitions committee; policy and procedures committee; and, a fellowships and scholarships committee. You are welcome to share contact information with him, and he is happy to reach out with more context to any who may be interested.

6. Report of the Interim Associate Dean for Diversity, Equity, and Inclusion, and Associate Director, Grace Jordan McFadden Professors Program (Toby Jenkins)

7. Report on Professional Development (Wright Culpepper)

Wright shared that the Professional headshot sessions scheduled for this Friday, February 26th, are at capacity.

The Graduate Career Consortium Virtual Career Expo is all day next Wednesday, March 3rd. We will be sending a reminder this week to students, Graduate Directors, Program Administrators, and CADO to promote the event.

The deadline for students to register as a presenter at Discover UofSC is next Friday, March 5th. Students may present in the poster or 3MT sessions. Training will be provided for both presentation styles in the coming weeks. Reminder emails have been and will continue to be sent.

We have added three new professional development opportunities since the January Graduate Council meeting. They are as follows:

A lengthy discussion occurred regarding ways to amplify graduate recruitment. Wright will put feelers out to see which programs may be interested in this endeavor and create an interest group to get this ball rolling. In addition, the topic of training for graduate students on how to use social media

for research and related topics might be very helpful. Graduate Council members can reach out to colleagues in their departments to see if there is an interest. The Graduate Council would be happy to support this effort if there is enough interest, and the Graduate Student Association (GSA) has also expressed interest in support of this initiative.

8. Report of the Graduate Student Association Representative (Sudipta Saha)

Sudipta reported that the GSA Executives met with Dr. Weldon, Interim Dean of the Graduate School, on Feb 10th and had an exhaustive discussion on issues regarding the graduate experience at the UofSC. GSA looks forward to working with Dr. Weldon to continue to serve for the graduate students.

GSA's next virtual Townhall is scheduled for March 10th, 3-5pm. Graduate School Interim Dean Weldon will be present as a guest speaker between 3-4pm.

GSA communicated with the Department of Integrated Information Technology (IIT) about the continuation of student email after graduation. As it stands now, the email account will be available for up to 2 years after graduation. But some other schools have taken a smarter approach such as a) incoming email can be redirected to new email after the 'cushion' period, b) Emails can be accessible/retrievable even if it is not active.

GSA elections have tentatively been scheduled for next month, March 30th - 31st. He will confirm at the next Graduate Council meeting.

Sudipta followed up by confirming that many graduate students have responded to GSA that the social media platform presence is very beneficial to them. GSA strongly supports promoting any events/trainings via social media to capture a much wider audience.

Dr. Wooten asked that the subcommittee members continue to work on the modification of the Academic Bulletin. They are currently modifying the draft of the table of contents and intend to move forward.
